
Global Health Watch III

In an increasingly globalised world with new crossborder threats to health, widening disparities in health and access to health care, and an unacceptable level of human suffering and premature mortality in many countries, people across the globe are asking, why is so little progress being made by in promoting health in the world?

The Global Health Watch is designed to seek answers to such questions and also to articulate solutions. It proposes an alternate vision of health located in a vision of equity, rights and empowerment. It is a collaborative civil society initiative, presently co-ordinated by the Peoples Health Movement, Medact, Medicos International, Health Action International and Third World Network. The Global Health Watch is contributed to by researchers, academics and activists from across the globe. Two editions of the Watch have been published: in 2005 as Global Health Watch II. The third edition of the GHW is to be published in mid-2011.

GHW III shall have the following broad sections:

- Analysis of the global political and economic architecture, within which are located the decisions and choices that impact on health.
- View of current issues and debates on health systems, to draw appropriate lessons and propose concrete actions for promoting health.
